Nominations

Additional nominations from the membership may be made by petition only; nominations will not be accepted from the floor on the day of the Annual Meeting. The nominating petition, a statement of qualifications and certification of

intent to serve if elected to office, must be received by the Board Secretary on or before January 27, 2020. Nominees accepted by petition will be added to the ballot for voting at the Annual Meeting after confirmation of signatures by the Supervisory Committee.

Voting at the Annual Meeting

Voting will be conducted by ballots distributed at the Annual Meeting on March 7, 2020. The voting period will be between 10:00am – 11:00am. Per Hawaii Central Bylaws, primary members on individual accounts and members on joint accounts, who are at least 16 years of age, are eligible to vote. The vote will be tallied by the Supervisory Committee, and the results will be announced the same day.

COMMUNITY OUTREACH GOAL ACHIEVED Friends of the Children's Justice Center



Hawaii Central's Team Keiki partnered up with Friends of the Children's Justice Center of Oahu (FCJCO) to help raise money for their Holiday Gift Project. FCJCO aims to wrap gifts for 366 child victims and their siblings. All gifts were chosen specifically for each child, as requested by professionals serving the children. Collectively Hawaii Central staff and our members raised a total amount of \$1,155.00. Hawaii Central used \$315.56 of the funds to purchase Christmas gifts for 15 keiki and donated the remaining \$839.44 to FC|CO.

Friends of the Children's Justice Center of Oahu, a 501(c)(3) nonprofit organization, has served thousands of child victims of sexual abuse, felony physical abuse, sex-trafficking or witnesses of a violent crime since its founding in 2010. With Friends' help, the Center is able to provide snacks, meals, and comfort items as well as essential items that fill foster care bags, which the Center gives to victims who must enter foster care. Through its Hoʻola Na Mana'o Program, FC|CO purchases goods and services that are crucial to helping victimized children heal after they leave the Center.

TAX TIME REMINDERS

The deadline to file your 2019 federal taxes is Wednesday, April 15, 2020. With tax time around the corner, keep an eye out for the following tax forms that you should receive from us no later than January 31, 2020:

- Form 1099-INT All members who have earned dividends in 2019 will receive a 1099-INT
- Form 1098 For Hawaii Central mortgage loans with interest paid in 2019

The tax forms will be sent in the mail. Members wishing to receive their 1099 earlier, may obtain it electronically by logging into ItsMe247 Online Banking. If you do not have access to your account via online banking, please visit hawaiicentral. org and click on the FIRST TIME USER button today!

If you're expecting a tax refund this year, expedite your refund by signing up for direct deposit. Just get your Hawaii Central account information from the bottom of your check or call us at (808) 536-3677 for assistance. Hawaii Central's routing number is 321378990.

Contributing to an IRA? Take advantage of the tax season by contributing to your Individual Retirement Account (IRA) for the 2019 tax year. You can contribute up to \$6,000 per year to your IRA, or \$7,000 if you're older than 50 years old. Don't have an IRA account yet? Consider opening one today to help save for your retirement.
